**Application:** Must be submitted two days in advance at the administration office. The permission to vendors is on first-come-first-serve basis and subject to availability of space and agreement to JIAR policies stated herein under.

**Vending Fee:** As per JIAR Board decision, a vending fee of \$10/day/setup is payable daily. If setup issues arise, JIAR will have final say to limit any setup equipment.

**Compliance:** Items and products sold must comply with local and state regulations and **MUST** be HALAL/Zabiha

**Space:** Vendors are to stay in the assigned area. Please do not block FIRE and Emergency EXITS. Only ONE table setup allowed at Friday Jummah

**Equipment:** Vendors bring their own setup equipment such as tables, displays, chairs and will not use JIAR utilities.

**Setup/Cleanup/ Dismantle** Vendors are responsible for setup, dismantle and cleanup of assigned space. JIAR reserves the right to remove equipment/display if interfering with JIAR safety or posing health risk.

**Dress Code:** Vendors are to follow Islamic dress code while vending (specially, NO Shorts please!)
