ARTICLE III			
Members			
<ul> <li>Section 1. Classes of Members. Jamaat Ibad Ar-Rahman, Incorporated shall have only one class of members. Membership is open to any person meeting the following qualifications:</li> <li>a) Belief is based on the Qur'an and Sunnah, and according to the methodology of the People of the Sunnah and Jama'ah, (i.e. the four main Mathahib (Islamic Schools of Jurisprudence): Hanafi, Shafi'i, Maliki and Hanbaly, and other Muslims who base their understanding exclusively upon the Qur'an and Sunnah of the Prophet Muhammad (Peace and Blessing of Allah be upon him) and the Sunnah of the four (4) right-guided Caliphs; Abu Bakr, 'Umar, 'Uthman and 'Ali, (May Allah be pleased with all of them);</li> <li>b) Conduct in accordance with the Qur'an and Sunnah;</li> <li>c) Participation in the work and affairs of the corporation;</li> <li>d) Non-membership in another organization or organizations having the same or similar purposes and objectives in the same locality as Jamaat Ibad Ar-Rahman, Incorporated; and</li> <li>e) Accepted application and payment of the annual dues (as determined by the Board of Directors)*.</li> <li>f) Be 16 years or older.</li> </ul>			
Section 2. Membership. Approval of membership shall be by majority vote of the Executive Committee.			
<b>Section 3. Voting Rights.</b> Each member shall be entitled to one vote on each matter submitted to a vote of the members. However, a member cannot vote on any matter pertaining to the affairs of the corporation until 60 days following his/her membership approval by the Executive Committee.			
<b>Section 4. Termination of Membership.</b> The Executive Committee, by affirmative vote of the majority of all of the members of the Executive Committee, may suspend or expel a member for cause after an appropriate hearing, and may, by majority vote of those present at any regularly constituted meeting, terminate the membership of any member who becomes ineligible for membership, or suspend or expel any member who shall be in default in the payment of dues for the period fixed in Article XII of these bylaws.			
<b>Section 5. Resignation.</b> Any member may resign by filing a written resignation with the Secretary. The Executive Committee may reinstate such former member to membership upon such terms as the Executive Committee may deem appropriate.			
Section 6. Transfer of Membership. Membership in this corporation is not transferable or assignable.
